#### **Notice of intended consolidation of existing pharmacy sites:**

Rowlands Pharmacy, Mayflower Way, Wombwell, Barnsley, S73 0AJ  
Rowlands Pharmacy, 5 George Street, Wombwell, Barnsley, S73 0DD  
(consolidation onto the site at Mayflower way).

The application has been granted on the grounds that it meets the requirements set out in Regulation 26A of the National Health Service (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013 (as amended).

L Rowland & Co (Retail) Ltd is included in the pharmaceutical list in relation to both Site 1 and Site 2 therefore no change of ownership application is required for Site 2 and Paragraph (4) of Regulation 26A does not apply.

Neither Site 1 nor Site 2 is a distance selling premise or an appliance contractor premise.

The applicant has confirmed that the current pharmaceutical services provided at Site 1 would continue to be provided consequent to the consolidation of the listed chemist premises at Site 1. There are no advanced or enhanced services that are currently being provided from Site 2 that have not been included in the list of services to be provided from the consolidated site. The applicant has confirmed that there would be no interruption to service provision.
