#### **Expansion of Childcare Funding from 1 April 2024**

The first phase of the biggest ever expansion of childcare starts giving working parents of two-year-olds access to 15 hours a week.

Thousands of parents of two-year-olds across the country are getting help with their childcare costs as the first phase of the biggest ever expansion in childcare starts.

In this first stage, working parents of two-yearolds are now able to access 15 hours a week of government-funded childcare from 1 April.



The rollout of support is part of the government's plan to help families – freeing thousands of couples from having to choose between having a family and a career, as over 150,000 children are on track to secure government-funded places from this week.

By September 2025 the full rollout will be completed, with working parents able to access 30 hours from the end of maternity leave to when their child starts school, saving parents an average of £6900 per year.

#### The Department for Education (DfE) has replaced the Governance Handbook

The DfE has published 2 new governance guides, to replace the Governance Handbook. There are no new requirements, so your board doesn't need to do anything other than to be aware that there is now a specific source of information for different types of school. You can find the guides here:

#### Ofsted – Big Listen Survey (closing date 31 May 2024) Overview

The Big Listen is an opportunity for Ofsted to hear from the professionals it works with, like teachers and other educators, carers, employers and social workers, and the people it works for: parents, carers, children and learners.

The consultation asks about:

- how Ofsted report inspection findings
- how Ofsted carry out inspections
- how Ofsted can have a positive impact on the sectors it inspects
- what Ofsted need to do to be a world-class inspectorate and regulator, trusted by parents, children and the sectors it works with

Ofsted want to hear views on the priorities for Ofsted that are important to people.

The questions highlight the areas that Ofsted want to hear from people about and will inform its thinking going forward. Ofsted want views on its future direction of work.



The Big Listen is more than just a consultation.

Ofsted have also commissioned research through focus groups with parents and education/care professionals, and will be holding a programme of events to speak directly to the different providers it inspects and regulates.

Ofsted will analyse responses and set out its plans later this year.

### National Governance Association (NGA): "From Classrooms to Communities" – a manifesto for schools and trusts

boards, the NGA manifesto for 2024 outlines the key challenges faced by schools and academy trusts and presents a set of bold proposals aimed at addressing these issues.

#### DfE funding of the "Inspiring Governance" School Governor Recruitment Service to cease

The Government has pulled the plug on a governor recruitment scheme – despite record-high vacancies. Funding will cease on 30 September 2024

The National Governance Association (NGA) said ditching the last remaining government-funded governance scheme means boards are now "left entirely to their own devices, with past support for governance recruitment, development, and training now all removed".

Inspiring Governance has helped recruit 8,000 school governors and trustees since it launched **inspiring** with Department for Education funding back in 2016.



Emma Balchin, NGA co-chief executive, said: "The decision to abandon funding for school governance is deeply concerning and sets a troubling precedent for the future."

In October 2023, the government also scrapped the national leaders of governance programme, which had been supporting struggling schools to improve their governance for ten years.

"Governance is pivotal in upholding standards and driving improvement within our education system," added Balchin.

"Without adequate financial support to support sustainable recruitment of volunteers, governors, and trustees' ability to fulfil their responsibilities effectively is jeopardised."



The NGA has written to the education secretary, Gillian Keegan, urging her department to "reassess its positions and acknowledge the irreplaceable role of governance in the education sector". The
